The Executive Officer, NAC Athgarh invites quotations in sealed covers from the intending register firms/agencies/Manufacture/dealers towards supply and installation of Vehicle Tracking system for NAC Athgarh.

The start and end date of sale of quotation from dt- 06.08.2024 to 12.08. 2024. Quotation should be reach undersigned on or before 13.08.2024 by 5.00 PM and will be opened on 14.08.2024 at 11.30 AM in the office chamber of the Undersigned in presence of the Quotationer or their authorized agent who intend to attend. The rate would be quoted shall be inclusive of installation, handing and transportation / delivery charges (Exclusive of GST). No extra cost on any account whatever will be admissible. Conditional Quotation will be rejected immediately. The rate should be written clearly and legibly without any error or overwriting and both in figures and in words. In case of difference or rates or any ambiguity over rates, then the rates written in words will be taken into consideration. Each "Quotation should furnish EMD of rupees 5000/- and the cost of bid document Rs.500/- (nonrefundable) in shape of DD/Challan showing Cash deposited at NAC Athgarh. Copy of Farm registration, GST registration, PAN Card along with copy of previous such orders and credentials issued by any Govt. Office/organization in favour of him/her/them. The sealed Quotation should be super-scribed on the cover as "Quotation for Supply installation vehicle tracking system". Further clarification can be obtained from this office. The undersigned reserves the rights to reject or cancel the said quotation without assigning any reason thereof.

Introduction of Mobile App is one of the popular platform to be adopted for enabling citizen services at the door steps of the Solid Waste generators. In order to implement the directives of the Govt. as well as the mandate of SWM Rules the mobile app will be the value addition to ensure Transformation through Team Work, Technology within time. Hence, Athagarh NAC intends to use an **Android app** through which bulk waste generators can intimate/ apply within real time GPS location data to the ULB authorities by depositing required User Fees and in turn ULB authorities pick up Garbage on real time basis at required location within the jurisdiction area.

Intending eligible registered firms/ organization/ societies/ individuals etc are required to go through the Bid Documents containing scope of work, technical requirement, eligibility criteria, paper cost, EMD etc and to submit sealed tender with all related documents including cost of Bid Documents and EMD to the To, The Executive Officer, Athagarh NAC within 7 days from the publication of this Notice.

- b. Minor changes to the process shall be addressed
