

The Executive Officer NAC, Athgarh invites percentage rate bids for the following works detailed in the table from the Class of Contractors as mentioned in Col.6 of table registered with the State Governments and contractors of equivalent Grade/ Class registered with Central Government/ MES/ Railways/ Athgarh NAC for execution of Civil Works. The bidders may submit bids for any or all of the works in the Table as enclosed separately.
2. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website: [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in).
3. Bid must be accompanied with scanned copies RC, GST, PAN & Relevant documents as per DTCN.
4. Bids must be accompanied with financial instruments towards **Tender Paper cost** in shape of DD in favour of "**Executive Officer, Athgarh NAC**", payable at Athgarh and the successful bidder should submit the Bid Security (E.M.D) will be in shape of TDR/ FDR/ KVP/ NSC or any Small saving instrument duly pledged in favour of **Executive Officer, Athgarh NAC**", payable at Athgarh as per the amount specified for the work in Col. 4 and 5 mentioned in the above table. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the State are required to furnish 2% of the amount put to tender put to tender as Bid Security.

6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
7. Bids shall be received only "**on line**" **on or before 5 P.M of 30.12.2024**.
8. The Original DD towards Paper cost, EMD and Affidavit should be submitted in a closed envelope prescribing the name of the work for individual work separately addressing to the Executive Officer, Athgarh NAC, Athgarh on or before **11.00 A.M. of 30.12.2024** i.e. before opening of the Bid.
9. Bids received online shall be opened at **11A.M. on 31.12.2024** in the office of the **Executive Officer, NAC, Athgarh** in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at



the same time and venue.

10. The Engineer contractor willing to avail the Exemption of E.M.D will submit the scan copy of affidavit to avail the exemption along with bid document and the original affidavit, original registration certificate shall be submitted in the office of the undersigned on or before date & time of opening of bid as specified Para-8 above during office hour on working days for recording necessary entry for exemption of EMD failing which the bid shall be rejected.
11. Engineer contractors who want to avail EMD exemption have to submit one affidavit with tender declaring therein to the effect that they have not yet availed 3 (three) nos of EMD exemption during the financial year 2023- 2024 and to show the original Registration Certificate to the tender opening authority for confirmation at the time of the execution of Agreement.
12. The Bid documents should be up-loaded by the Bidders on-line in [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) accompanying the clear scanned copies of self attested Registration certificate, GST registration certificate, PAN card, No relation certificate and affidavit about the authenticity of the tender documents and Affidavit to avail price preference/ Exemption of EMD in case of SC/ ST/ Contractors/ Physically Handicapped contractor. Non submission of Bid security and cost of tender papers within the designated period shall debar the bidder from participating in the online bidding system and also his portal registration shall be blocked. His name shall be reported to the registration authority for cancellation of his / her registration as contractor as per Works Deptt. No. F.A.R- 3/08-1027/W dt.24.01.2009.
13. Engineer contractors, SC/ ST/ Contractor and Physically handicapped contractor who want to avail EMD exemption/Price preference have to produce original affidavit/No relation certificate at the time of execution of Agreement and to show the original Registration Certificate, GST registration certificate, PAN card to the tender opening authority for confirmation at the time of execution of Agreement for verification
14. The original documents of scan copies furnished in e-tendering process by the bidder shall be submitted in the time of agreement of work.






